- (d) what is the present price of bulk drug and on what price present formula tion prices are fixed;
- (e) whether it is a fact that the Ministry has given price increases on *suo motu* basis; if so, the names of drugs and the extent of price increase allowed to each under DPCO, 1987; and
- (f) what are the names of drugs where *suo* motu price reduction was given and to what extent?

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI EDUARDO FALE-IRO): (a) to (f) No, Sir. Of the seven price fixation/revision notifications of bulk drugs issued in March, 1994, the price revision notification issued on 18-3-1994 involved reduction of the price of the bulk drug Iodochloro hydroxyquinoline from Rs. 397 to Rs. 389 per Kg. The notification has not been withdrawn.

(to when the prices of. formulation were fixed and at what mice of bulk drug and what were the earner prices and present prices of each strength and each pack of formulation; and

(c) what are the names of producers of bulk, drugs and production of each since 1987 per year, year-wise?

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI EDUARDO FALE-IRO): (a) No instance of violation of provisions of DPCO, 1987 has come to the notice of the Government.

(b) The prices of following ceiling packs of formulations based on the bulk drug Ranitidine were fixed on 20-6-1988 on the basis of weighted average import price of Rs. 4,396 kg.
