

(c) what is the criterion on which Government evaluate efficiency of PIB; and

(d) whether writing feature articles, releasing photo prints and organising press conferences are only measure of the efficiency of PIB, if not, whether there are other important determinants therefor?

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI K.P. SINGH DEO):

(a) and (b) No, Sir. In a majority of cases the agency news items are based on the information/material supplied by PIB or briefings provided by PIB/ Ministry's officials.

(c) and (d) PIB acts as an interface between Government and the media. Drawing of publicity plans, advising Ministries/Department on their publicity approach, providing feedback to Decision makers and providing media/PR conse-ling to Government are other important measures that reflect the efficiency of PIB.

#### **Establishing the Metro Channel and Earth Transponder at Ahmedabad**
