- (a) whether it is a fact that an American Company AT&T has made any agreement with the Ministry for I.S.D. System; and
 - (b) If so, the details thereof?

THE MINISTER OF STATE OF THE MINISTRY OF COMMUNICATIONS (SHRI SUKH RAM): (a) Yes, Sir.

(b) Bilateral agreement between the Videsh Sanchar Nigam Ltd., and AT&T according to the international regulations and conventions in respect of out-going and in-coming telephone traffic, accounting rates, tariff etc.

- (b) Two new proposed exchanges are likely to be commissioned by March, 1994. About 5200 Telephone connections are likely to be provided after commissioning of the above exchanges.
- (c) and (d) 8th Five Year Plan of the Department of Telecommunication envisage Waiting List period not to exceed two years in large telephone systems like Nagpur. Expansion plans are being drawn accordingly.
