Migration of Rural People to Urban Areas

- MINISTER OF STATE THE MINISTRY OF URBAN DEVE-IOPMENT (SHRI P. K. THUNGON): (a) According to 1981 Census, 33,44 million people were enumerated in urban areas of India whose place of last residence was in rural areas i.e. who were rural urban migrants. Data of 1991 Census pertaining to migration has not been published so far.
- (b) To the extent possible within the outlays available basic amenities are proin slum localities which are generally the places where migrants. The amenities include: drinking water, low cost sanitation, approach and internal roads.

street lighting, pre-school/primary edu-cation, primary health care, etc. Various schemes such as Urban Basic Services for the Poor (UBSP), Nehru Rozgar Yojna (NRY), Low Cost Sanitation for Liberation of Scavengers (LCS), Economical Weaker Section Housing (EWSH) and Environmental Improvement of Urban Slums (EIUS) are under implementation in urban areas to provide basic amenities and other support services including employment to the urban poor migrants.

- (c) The reasons for such migration are mostly socio-economic: in search better job opportunities and better living and out of desparate rural living condi-tions. The other reasons are political, communal disturbance, education, marriage,

Firstly, implementing programmes for generating more employment opportunities and creation of better facilities in the rural areas by implementing schemes like Intergrated Rural Development Programme (IRDP),
 Jawahar Rozgar Yojana (JRY), Development of Women and Children in the
 Rural Areas (DWCRA) and Accelerated Water Rural Supply **Programmes** (ARWSP). These schemes are implemented by the Ministry of Rural Development. Secondly, by giving greater emphasis on the development of infrastructure on small and medium towns for creating employment opportunities and growth potential under the Scheme of Integrated Development of Small and Medium Towns (IDSMT).
