- (b) whether it started in the interest of augmenting the development projects in the country for any other purpose;

- (d) whether Government are aware that Government organized Lottery System is at present spelling doom for millions of families throughout the country; and
- (e) if so, what action Government propose to take to regulate the great lotterv bazar hawking hopes ultimately bringing in ruination for lakhs of people particularly in the lower strata of society?

THE MINISTER OF STATE IN THE MINISTRY OF HOME **AFFAIRS** (SHRI P.M. SAYEED): (a) to (c) Lotteries have been started to augment the recources for various devlopment projects in the country. A large number of people are directly or indrectly involved in this business.

(b) and (e) Complaints regarding malpractices in lottery business received from time to time which are forwarded to the concerned Governments / UT Administrations for further necessary action. According to entry 40 of List I of Seventh Schedule of the Constitution Lotteries organized by Government India of OF Government can be regulated by a law enacted by the Parliament. No State Government can make a law relating to Government Lottery. Under Article 298 (b) the executive power of the State extends to carrying on business and making contracts for any purpose. In the

absence of a law of the Parliament regulating Government of India / State Government Lotteries. Governments been conducting have lotteries by exercising the above executive power. As regards Power to regulate Private lotteries Entry 34 of List II relating to "Betting and Gambling" extends the Legislative Competence of State Legislations to cover regulation of private lotteries. State Governments are primarily responsible for checking the malpractices and to regulate the lottery bazaars. Central Government has issued guidelines from time to time since 1984 to the States / UTs to regulate the lottery business.
