## Allocation of rice and sugar to Orissa

4253. SHRI RAHASBIHARI BARIK: Will the Minister of CIVIL SUPPLIES, CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION be pleased to state:

- (a) whether there has been increase in the demand of rice and sugar by the consumers of Orissa;
- (b) if so, the steps proposed to be taken to enhance rice and sugar allocation to Orissa;
  - (c) the projection made for 1994; and
- (d) the steps taken in that direction so far?

THE MINISTER OF STATE IN THE CIVIL SUPPLIES, MINISTRY OF CONSUMER **AFFAIRS** PUBLIC & DISTRIBUTION (SHRI KAMALUD-DIN AHMED): (a) and (b) Allocation of wheat to Orissa was increased from 20,000 tonnes in October, 1993 to 25,000 tonnes in November, 1993 and again raised to 30,000 tonnes from March, 1994 to June, 1994. An additional allocation of 5,000 tonnes has been made to the state for a period of 4 months from May, 1994 to August, 1994. The allocation of rice to the state is 38,700

tonnes per month. Request for increase in the levy sugar allocation could not be acceded to due to constraints in the availability of levy sugar.

(c) and (d) All State Governments/ UT Administrations including Orissa, were requested to work out a realistic monthly schedule of requirement for the PDS taking into account the seasonal availability of foodgrains in the open market. Projection have not so far been received from the Government of Orissa.
