#### Statement

The steps taken by the Government to reduce pollution levels include the following:

- 1. Effluent and emission standards have been prescribed.
- 2. Ambient Air and Water Quality Standards have been evolved.
- 3. A network of ambient air and water quality monitoring Stations has been set up.
- 4. Industries have been directed to comply with the prescribed standards on a time bound basis.
- 5. Fiscal incentives are provided for installation of pollution control equipment and shifting of polluting industries from congested areas.
- 6. A scheme for setting up of common effluent treatment plants in cluster of small scale industrial units has been taken up.
- 7. In order to prevent industrial pollution in future and to facilitate sustainable development, the Government has made it compulsory for major specified projects to have environmental clearance based on impact assessment and associated studies prior to site selection.
- Cross and mass emission standards for all vehicles have been notified under the Motor Vehicles Rules, 1989.
- 9. Ambient Air Quality Standards in respect of noise have been notified.
- 10. The Central Pollition Control Board has evolved codes of practice for controlling noise from sources other than industries and automobiles. These include public address system, air craft operation, railway operation, construction activities and bursting of crackers. This has been sent to all the State Governments with a request to advise the concerned Departments of the State to implement these codes of practices under the relevent local acts.
- Noise limits for automobiles domestic appliances and construction equipment have been notified.
- 12. Public awareness campaigns have been launched.
