

### Commissioning New Jetty at New Mangalore Port

4836. SHRI B. K. HARIPRASAD : Will the Minister of SURFACE TRANSPORT be pleased to state :

(a) whether it is a fact that the Public Investment Board has cleared the project for the creation of an additional jetty at the New Mangalore Port;

(b) whether there are any plans to renovate the existing jetty which has gone obsolete and requires upgradation to handle higher traffic; and

(c) what is the time frame set to commission the new jetty facility and whether Government would ensure its completion in time to handle the input traffic of the Mangalore Refinery supposed to be functional from August, 1995 ?

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE TRANSPORT (SHRI JAGDISH TYTLER) : (a) Yes, Sir.

(b) The proposal envisages creation of na additional oil jetty and upgradation of the existing oil jetty to cater to the needs of the users.

(c) The completion time for the entire project has been estimated at 30 months from the date of Government Sanctions However, the new oil jetty is expected to be completed earlier than 30 months to make it available for use tankers.

Assurance to Gujarat for Ahmedabad Project from National Renewal Fund

(c) what was the total length of National Highway projected to be completed during the Fifth, Sixth and Seventh Plan period and what was the actual achievement stating the reasons for the shortfall in the target and

(d) what are the reasons for the discrimination, if any, in the allocation of funds and in taking up the National Highway Projects in the less developed States in the country ?

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE TRANSPORT (SHRI JAGDISH TYTLER) : (a)

A Statement-I showing the Statewise length of National Highway is attached. (*See below*).

(b) to (d) The development of National Highways is a continuous process. The improvement works are taken up keeping in view the condition of the road, traffic intensity, inter-se-priority of work and the overall availability of funds etc. The Plan-wise and State-wise details of allocation during the last three Five Year Plans is enclosed as a statement-II, (*see below*).

The allocation for National Highways to various states is made keeping in view the Bank of Sanction, status of work and the availability of funds. There is no discrimination in the allocation of funds to various States.
