item in Hindustan Times dated 14-3-94 where the Pakistani PM threatened to raise the Kashmir issue over and over again During the 50th. in international fora. session of the UN Human Rights Commission. Pakistan had tabled a resolution on alleged human rights violations in J&K which called for a fact-finding mission to be sent to J&K. However, as a result of intense lobbying by India, Pakistan was isolated and following an appeal by Iran and several other countries. Pakistan withdraw the proposed resolution. Iranian appeal to Pakistan to withdraw the resolution also referred to facilitation of a visit by envoys from Islamic countries by India to J&K.

Written Answers

Pakistan's withdrawal of the resolution was voluntary and unconditional. The Iranian statement was made unilaterally and is not binding on India.

The Government of India is vigilant on all steps being taken by Pakistan to internationalise the Kashmir issue and to thwart any media war being unleashed by Pakistan. Prior to and during the UN Commission on Human Rights Session, India had repeatedly drawn the International Community's attention to the true facts regarding the situation in J&K and Pakistan's interference in India's internal affairs by aiding and abetting terrorism in India. Pakistan's isolation at the 50th UN Human Rights Commission Session is a vindication of our efforts to thwart any Pakistani effort to internationalise J&K issue

Dialogue with Pakistan in Kashmir issue

BHATIA): (a) and (b) On 21 March, 1994 Government reiterated to the Government of Pakistan its readiness to resolve all outstanding issues, including differences relating to J&K, peacefully and through bilateral negotiations within the framework of the Simla Agreement. Accordingly, Government have proposed that the Eighth round of Foreign Secretary level talks be resumed either in New Delhi or Islamabad. Pakistan has not yet conveyed its response to this proposal.
