(d) The endeavour is to highlight the areas of concern in respect of the intersectoral linkage vis-a-vis mismatch with a view to enabling to administrative ministries to initiate corrective actions and fulfil their production targets.

Individual State themselves Governments formulate employment and development strategy appropriate to each State.

(c) to (e). According to the Eighth Plan and Annual Plan documents of the Government of Gujarat, the Eighth Plan of the State is structured as part of a long term ten year strategy to eliminate poverty and unemployment. The Plan lays emphasis on employment promotion through diversification of the economy of the State, raising the growth of productivity and employment in small scale sector, provision of training and

skill for productive employment to one million workers, promotion of tiny, cottage and village industries, self-employment especially in non-traditional activities, rural infrastructure, afforestation, minor irrigation and development of backward areas.
