Fall in industrial growth of infrastructural sectors

*454. SHRIMATI KAMLA SINHA: Will the PRIME MINISTER be pleased to state:

- (a) whether it is a fact that the industrial infrastructural sectors registered a fall of 2.6 per cent in the first eight months of the financial year 1993-94, with a growth rate of 5.6 per cent as against the targetted 8 per cent;
- (to) whether the sectors which registered the most significant fall in growth were crucial areas like fertilisers, crude oil, saleable steel, Railways and cement;
- (c) if so, what are the details thereof; and

(d) what steps Government intend to take to halt this industrial decline and encourage industrial growth in the core sectors?

(d) The Standing Committee of Secretaries on industrial infrastructure regularly monitors the performance of key infrastructure industries for taking necessary remedial measures. In the budget for 1994-95, plan outlay for infrastructure sectors has been increased. Besides, private investment is now being invited in power, steel and petroleum sectors to supplement public and Government resources.

Reimposition of Control on Price and **Distribution of Molasses**

*455. SHRI KRISHNA KUMAR BIRLA: SHRI GHUFRAN AZAM:

Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state:

- (a) whether there is persistent demand to reimpose controls on price and distribution of molasses and alcohol:
- (b) if so, whether the alcohol based chemical units are losing their viability due to decontrol of molasses;
- (c) if so, the reaction of the Union Government thereto?

THE MINISTER OF CHEMICALS AND FERTILIZERS (SHRI RAM LAKHAN SINGH YADAV): (a) to (c) The alcohol based Chemical Industry has been persistently requesting for remposition of controls over the movement and price of molasses and alcohol. They have represented that such controls are required to ensure adequate availability of molasses and alcohol at controlled prices.

This is one of the issues that came up for discussion in a Conference of State Excise Ministers held on 4-11-1993. A Group of State Excise Ministers under the chairmanship of the Karnataka Chief Minister is now looking into this issue among others.

Demand of Foreign Airlines for more Destinations

The traffic lights to foreign airlines are, however, granted after negotiation with the respective Governments on the bash of [reciprocity of benefits to the two sides.
