### **Inadequate cargo facilities at various airports**

Will the Minister of CIVIL AVIATION AND TOURISM be pleased to state :

(a) whether the cargo handling facilities at various airports in the country are inadequate;

(b) whether there is an urgent need to develop more cargo terminals at various airports;

(c) if so, the reaction of Government thereto;

(d) whether any study has been conducted to check the bottlenecks in the existing systems at various airports; and

(e) if so, the details in this regard ?

THE MINISTER OF CIVIL AVIATION AND TOURISM (SHRI GHULAM NABI AZAD) : (a) to (c) Generally, cargo handling facilities at the five international airports are adequate. However, facilities at most domestic airports are either inadequate or not available. International Airports Authority of India (IAAI) is putting up additional facilities for smooth movement of cargo at Delhi, Bombay and Madras airports. Calcutta and Trivandrum airports have sufficient capacity at the moment, but taking into account the growth potential, facilities would be upgraded during the 8th Plan period. So far as domestic airports are concerned, upto now only agencies of some of the State Governments were

handling cargo of their respective States. At Coimbatore and Salem, the National Airports Authority (NAA) is creating facilities for this purpose. During the 8th Five Year Plan, IAAI has plans to invest Rs. 54 crores approximately on cargo expansion and warehouse facilities and NAA has plans to invest Rs. 25 crores approximately for this purpose.

(d) and (e) The Ministry of Commerce has on 28-8-93 constituted a Task Force Committee to assess the future needs of air cargo at domestic and international airports. Besides, World Bank team also carried out a study about requirement of cargo facilities at International Airports.

(c) The target fixed for 1994-95 under CRSP for Orissa is 9600 sanitary latrines.
