#### Subjects on Social awareness at undergraduate level

\*469. SHRI P. UPENDRA: Will the Minister of HUMAN RESOURCE DEVE-LOPMENT be pleased to state:

- (a) whether the University Grants Commission has decided to include subjects like AIDS, the menace of drugs, environmental degradation and population explosion in the syllabus at the undergraduate level; and
- (b) if so, by when these subjects are likely to be included in the curriculum?

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI ARUN SINGH): (a) and (b) According to the information furnished by UGC, the Commission has drawn up an Action Plan which, inter-alia, contemplates introduction of a self-study courses on AIDS, Population Education, Drug Abuse and Environmental Education in all Universities and Colleges. The Action Plan has been forwarded to all the Universities for their comments by April 30, 1994 so that some of the action could be initiated by UGC from the academic year 1994-95.

Will the Minister of HUMAN RE-SOURCE DEVELOPMENT be pleased to state:

- (a) what are the details of provisions which govern the preparation and operation of panel of candidates selected for the post of Assistant Commissioners of Kendriya Vidyalaya Sangathan;
- (b) whether these conform to those of the Government of India in this regard;
- (c) whether these have since been adhered to while appointing Assistant Commissioners in Kendriya Vidyalaya Sangathan in March/April. 1994; and
  - (d) if not, the reasons therefor?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) and (b) The posts

of Assistant Commissioners are filled up in accordance with recruitment rules for the post. The rules envisage 40% of the posts to be filled up by promotion and 60% by direct recruitment. Promotions are made on the basis of panel recommended by the Departmental Promotion Committee and direct recruitment is made on the basis of open selection and panel made by the selection committee on that basis.
