He has been produced before the taluk Executive Magistrate who remanded him to judicial custody for three days. He has been lodged in the Bangalore Central Prison as 'A' class prisoner"

**Need to Check Fake Universities  
and Vishwavidyalayas in the  
Country**

SHRI KRISHNA KUMAR BIRLA (Rajasthan): Mr. Vice-Chairman, Sir, my Special Mention concerns the functioning of certain fake universities in the country. The recent revelation of the University Grants Commission about the functioning of as many as 25 self-styled universities and vishwavidyalayas in the country without any legal sanction and in blatant violation of the UGC norms and guidelines. In spite of the UGC's clear advice to the students not to pursue the courses offered by these self-styled universities, the functioning of such fake universities is not only astonishing but also a matter of deep concern. Under the UGC Act, these fake and unauthorised educational institutions are neither

entitled nor competent to award degrees/ diplomas/certificates as these are not recognised and the degrees awarded by these universities have no validity for academic and employment purposes. Yet the unwary students are lured by these fake universities on false promises.

Sir, it is ironic and unfortunate that the mushrooming of such illegal and unauthorised educational institutions is not being disallowed in the country. The revelation of the UGC by notifying such universities and vishwavidyalayas in their recent Press communique is not the end in itself. The Government's policy in respect of educational institutions lacks comprehensiveness and a will to implement it.

Therefore, it is high time that the Government gave its serious

consideration to the problem and took positive measures and if need be, by bringing a suitable legislation, to firmly curb the growth of educational institutions which have no legal entity and which are functioning with the sole objective of earning money by exploiting the innocent students. The Government should also immediately take appropriate action against such universities and vishwavidyalayas which have been identified by the UGC as fake and illegal. If necessary, the Government should prosecute them.
