If you want to continue the TADA, please check the misuse and abuse and punish those who are indiscriminately using it, who are extorting money, in Gujarat, in Maharashtra and in Andhra Pradesh. Re Absorption of employees of Regional Rural Bank of Sri Nagar in the State Bank of India.

**श्री सुन्दर सिंह धंधारी** (राजस्थान): मैडम, आपकी पार्टी में एक छोटे और अहम सवाल की तरफ सरकार का ध्यान आकर्षित करना चाहता हूँ। इलाहाबाद देहाती बैंक श्रीनगर में स्टेट बैंक का स्पांसर किया हुआ एक बैंक था। लेकिन वहाँ बहुत झलात खराब हो जाने के कारण उस के करीब 192 कर्मचारी आज वहाँ से विस्थापित हो गए हैं और हिन्दुस्तान के कई शहरों में आज वह रह रहे हैं। पिछले चार सालों से उन की मांग है कि या तो उन को ऐम्बार्क कर लिया जाए स्टेट बैंक में यह इस सारे बैंक को ही स्टेट बैंक में ऐम्बार्क कर लिया जाए। चार साल से मंत्रियों के द्वारा सेक्रेटरीज़ के द्वारा एक ही जवाब मिल रहा है—बी आर लुकिंग इंटर दि मैटर"। अभी तक इस मामले पर फैसला नहीं हुआ। 10-11 महीने से इन लोगों की तनख्वाहें बंद हैं। अब यह समझ में आ सकता है कि ये कर्मचारी अगर इनके मामले को तय नहीं किया गया है और तनख्वाहें बंद रही तो इनके ऊपर क्या मुसीबत आज ग़ुज़र रही होगी। बहुत छोटी छोटी संख्या में ये लोग अलग अलग शहरों में हैं। इन्दौर में एक है, चंडीगढ़ में चार हैं, जयपुर में दो हैं, बंगलौर में दो हैं, बम्बई में दो हैं, दिल्ली नेशनल कैपिटल रीजन में 40 हैं और जम्मू शहर में बकाया लोग हैं। उनकी मांग बिल्कुल जाज़िब है कि इनको स्टेट बैंक की सर्विस में ले लिया जाए और इनकी तनख्वाह जल्दी दिलाने का इंतज़ाम किया जाए। मैं यह आग्रह करना चाहता हूँ कि सरकार इस मामले पर जल्दी से जल्दी फैसला करे।

**Re. More Sugar to Tamil Nadu**

SHRI S. AUSTIN (Tamil Nadu): I urge upon the Government to allot additional sugar to tide over the shortage experienced in Tamil Nadu. Our hon. Chief Minister has requested the Central Government for increased allotment of sugar to Tamil Nadu in proportion to its population. But the Centre has been allotting only 22,457 tonnes of sugar which was decided seven years ago on the basis of population at that time. The Centre had been giving an extra 1,127 tonnes of sugar since August, 1991 but, this also has been withdrawn since March this year. Tamil Nadu needs at least 31,000 tonnes of sugar to meet the requirement from PDS. Under the

directions of our hon. Chief Minister to give ration cards to all the needy people, 27 lakhs new ration cards were given last year alone. These new cards alone need 5,400 tonnes of additional sugar. Since there is a difference nearly four rupees per kilogram between the PDS shop and the open market, people prefer to buy sugar from the civil supplies outlets only. Because of the gap between public demand and Central allotment of sugar there is shortage for which the State has to take the responsibility to tide over the shortage. The Tamil Nadu Government had demanded a monthly allotment of 10,000 tonnes of sugar immediately. So, I now appeal to the Central Government to meet this demand and release additional quota of sugar without delay. Thank you, Madam.

Instead of implementing it, the USA has come forward threatening Cuba with naval blockade. Sir, this is a very serious situation. America is emboldened to impose its will, maybe, through the use of its might and also subverting democratically elected Governments.

In India, America does not like the research and development of our defence

weapons. It pressurises other countries not to supply us technology and other materials. About Kashmir, it is taking a consistent anti-India position. If America's attempt goes unopposed, that will be a threat to democracies. America is trying to bring their own form of Government, their puppet Governments in most of these countries in the Third World countries. So, I would like to appeal to this august House to join with all freedom-loving people in opposing America's attempt to create subversion by imposing naval blockade.
