Compensation paid to voluntary retired employees of Super Bazar

728. SHRI DILIP SINGH JUDEV: Will the Minister of CIVIL SUPPLIES CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION *be* pleased to state:

- (a) the names and designation of Super Bazar personnels of the rank of Deputy General Manager, Managers, and Members of Executive: Committee who were to retire in the next three to four years but were allowed voluntary retirement in 1992 by the Management and the amount of compensation paid to them by Super Bazar with reasons and justification for allowing the retirement in each such case;
- (b) whether it is a fact that a number of retired persons including those who opted for voluntary retirement from Super Bazar on different posts have been given other types of assignments in different offices/ untis of Super Bazar; and
 - (c) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF CIVIL SUPPLIES CONSUMER, AFFAIRS AND PUBLIC DISTRIBUTION (SHRI KAMALUDDIN AHMED): (a) to (c) Super Bazar has informed that Voluntary Retirement Scheme has not been introduced in the Super Bazar. Hence the question of compensation paid to different categories of employees under this scheme does not arise.

National income spent on development of Super Bazar

- (a) the percentage of National In come being spent on the develop ment of Super Bazar during the last three years;
- (b) the percentage thereof being spent on General Manager and other higher officials;
- (c) whether the percentage is lower for staff/employees of class III and IV during the above period; and
- (d) if so the manner in which Go vernment propose to attain the goal of employees' betterment and bene fits?

THE MINISTER OF STATE IN THE MINISTRY OF CIVIL SUP-PLIES CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION (SHRI KAMALUDDIN AHMED); (a) The Central Government provides financial assistance under thie Central Sector Scheme to Super Bazar by way vi share capital, loan and subsidy for implementing certain specific schemes/projects related t_0 the expansion and development of the Super Bazar. For the years' 1991-62, 1992-93 and 1993-S4_ the Government released Rs. 76.00" lakhs, Rs. 38.30 lakhs and Rs. 20 lakhs respectively.

- (b) and (c) The establishment exnenses of Super Bazar, including salaries to the employees of Super Bazar and to those who are working in Super Bazar on deputation, which are paid in accordance with their sanctioned scales of pay, are made out of its business profits.
- (d) Financial benefits and allowances i_n the form of HRA, Medical allowance and reimbursement, Conveyance allowance, entertainment allowance etc. to the employees *oi*. Super Bazar are released in accordance with the facilities sanctioned to them by the Managing CDmmitte* of Super Bazar:
