Poor Health Services in Jammu and Kashmir

1182. SHRI VIRENDRA KATARIA:
Will the Minister of HEALTH AND
FAMILY WELFARE be pleased to state:

- (a) whether it is a fact that the health services in Jammu and Kashmir have become dismal with each passing day with State run hospita's and dispensaries failing to cater to the growing medical needs of the people; and
- (b) what measures Government are taking to mitigate the sufferings of the people in the State of Jammu and Kashmir?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. C. SILVERA): (a) and (b) Apart from the shortage of medical and para medical personnel in the Valley, no such failure of State Government Hospitals/Dispensaries in meeting the medical needs of the people has been reported.

Cases of AIDS in Eastern States

1183. SHRI BHAGABAN MAJHI: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) the number of AIDS cases reported from Eastern States and specifically from Southern Orissa;
- (b) whether AIDS cases are on the increase in the Eastern States;
 - (c) if so, the reasons therefor; and
- (d) the details of the steps being taken to check the spread of AIDS from those parts of Eastern States?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. C. SILVERA): (a) 20 AIDS cases have been reported from West Bengal as on 30th June, 1994. From the States of Orissa and Bihar no AIDS case has been reported so far.

(b) and (c) With improvements in clinical diagnosis and reporting system, there

have been more reports of AIDS cases from all over the country. Comparitively however, there are lesser reported cases of AIDS from the Eastern States.

(d) A comprehensive National AIDS Control Programme is currently under implementation throughout the country including Eastern States. The Programme consists of generation of awareness amongst risk behaviour groups and the general public, prevention and control of STD, promotion of condom use for prevention of STD, HIV Blood safety and rational use of blood and better facilities for surveillance, diagnosis and management of HIV/AIDS cases.

New vaccines for Leprosy, Malaria and AIDS
