In case of companies, the Ac' envisaged that a mining lease/prospecting lincence can be given only to .i company in which majority of the Directors were Indian citizens and *no'* less than sixty per cent of the share capital was held by pesrons who are either citizens of India or companie\* as '.lefmed in the companies Act,

1956. This Act was amended on 25-1-1994 and it now permits grant of a prospecting licence or a thing lease only to a company as denned in sub-section (1) of section 3 of the Companies Act, 1956.
