CBSE. The majority of the schools in the country are with the State Governments wh_0 have autonomy in design of curricula for schools under their respective jurisdiction.

Ic) and (d). As per information received from the Indira Gandhi National Open University (IGNOU), an academic programme in the area of Consumer Protection has been designed by the University to train the persons who wish to take up leadership of Consumer Protection Movement at various levels. The State Governments have not been approached so far to take initiative in introducing this subject at various levels since the IGNOU's academic programme is yet to be implemented in consultation with the Ministry of Civil Suplies, Consumer Affairs and Public Distribution.
