There is a prescribed procedure laid down for reply of Audit Paras and furnishing Action Taken Notes on C&AG's observations. The draft Action Taken Notes are to be processed in consultation with the implementing Agencies/organisations and Audit. Action Taken Notes are furnished to PAC Branch through the Ministry of Finance. The Ministry is meticulously following the prescribed procedure in dealing with the audit objections/C&AG observations.

## Technological Mission on Literacy
