Appointment of distributors for LPG in Changland and Seppa in Arunachal Pradesh

2175. SHRI NYODEK YONGGAM: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state;

- (a) whether Government have received any official correspondence from the Government of Arunachal Pradesh for appointment of LPG distributorship at Changlang and Seppa in Arunachal Pradesh to meet the long pending demand of the people of those backward areas; and
- (b) if so, what are the reasons of delay to appoint such distributorship?

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM AND NATURAL GAS (CAPTAN SATISH SHARMA); (a) and (b) Requests are received from time to time for setting diffeup of LPG distributorship from rent parts of the country, including Arunachal Pradesh Subject to economic viability and product availability, LPG distributorships are opened at unrepresented district headquarters and places having population of 20,000 and above manner. The locations in a phased Changlang and Seppa have been identified for inclusion in the next LPG Marketing Plan.

Increasing demand of LPG

- (a) whether it is a fact that the demand for LPG has become so tremendous that it is not possible to meet the same with the present pace of supply; and

NATURAL GAS (CAPTAN SATISH SHARMA): (a) and (b) The potential demand of LPG has been considerably higher than the indigenous availability. However, the demand of existing LPG consumers is being met by and large in full Plans have been drawn for higher availability of LPG by increasing the capacity of existing production sources, putting up new plants and augmenting through higher imports. order to increase the availability of LPG in the country in addition what is available through public sectoroil companies, Government in February, 1993, has decided to allow the import and sale of LPG by private agencies.

Maintenance of price discipline in marketing of Petroleum products by private Companies

- (a) whether it is a fact that Government introduced under a parallel marketing scheme, import by private entrepreneures of petroleum products and its marketing in the domestic market;

- (c) whether Government also stipulated in the said scheme any clause to maintain price discipline for the said petroleum products in the domestic market; and
- (d) if so, the details thereof; and if not, the reasons therefor?
