THE MINISTER OF STATE, IN THE MINISTRY OF INDUSTRY (SHRIMATI KRISHNA SAW): (a) No, St.

- (c) Industrialisation of a State is primarily the responsibility of the State Government concerned and the Central Government supplement their efforts wherever possible. Government of India is operating a Growth Centre Scheme for provision of basic infrastructural

or dispersal of industries. In addition, the Finance Act, 1994 has also introduced a Five Year Tax Holiday which will be available to mdi'^trial undertakings set up in notified backward districts.

THE MINISTER OF STAFF IN THt, MINISTRY OF INDUSTRY (SHRIMATI KRISHNA SAHI): (a) The recommendations of the Goswami Committee Report on Industrial Sickness and Corporate Restructuring are under consideration of the Government.

- (b) Data on sick industrial units assisted by banks in the country is compiled by the Reserbe Bank of India. According to the lastst RBI data, at the end of September, 1992, 233441 units in small scale sector and 1599 units in non-small scale sect:)/ were sick. Outstanding Bank credit against the sick units are Rs. 3345.54 crores and Rs. 6804.52 crores, respectively.
- (c) Government has taken a number ot stps for revival of sick industrial units. Some of the important steps are given 'i* enclosed Statement.
