Change in the Cropping Pattern

**THE MINISTER OF STATE IN THE

ARVIND NETAM):** (a) There is no significant change in the cropping pattern during the last three years;

(b) There is only marginal increase in area under horticulture crops which have export potential. As regards foodgrains, there is some increase in area under fine quality of rice variety and durum wheat which have also export potential.

(c) The area under rice and wheat, the two major foodgrains, has not shown any declining trend during the last three years. The marginal increase in area in some of the export oriented crops will not have any adverse impact on food security of the country.
