

management, arid and semi-arid crop production, plant and animal sciences, veterinary science, farm mechanisation and technology, agro forestry etc.

Cooperation under the Agreement is to be carried out through biennial Work Plans. A draft Work Plan for the period 1994-95 containing specific proposals for cooperation is presently under consideration of the Israeli side.

#### Production of Pulses

2469. SHRI V. HANUMANTHA RAO: Will the Minister of AGRICULTURE be pleased to state:

(a) whether government have formulated a policy for increasing production of pulses in less-irrigated areas;

(b) whether any places have been selected in Andhra Pradesh to be the focus of programmes for cultivation of pulses;

(c) if so, the details of such programmes in Andhra Pradesh; and

(d) the amount of funds earmarked for such a programme?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI S. KRISHNA KUMAR): (a) Yes. Sir.

(b) and (c) Guntur, Krishna, Karimnagar, Khamam, Mehboobnagar, Nalgonda, Rangareddy and Warangal districts of Andhra Pradesh State have been selected under the Centrally Sponsored National Pulses Development Project (NPDP).

Under this project the basic key inputs like production and distribution of seeds, sprinkler sets, improved farm implements, Dal Processors, Integrated Pest Management (IPM) Rhizobium culture, micro-nutrients and Training are provided to the farmers on subsidised rates. In order to disseminate the latest production technologies on farmers' field frontline and Block Demonstrations are being organised. The cost of the project is shared by the Govt of India and the States on 75:25 basis.

(d) The total allocation for Andhra Pradesh for the year 1994-95 is Rs. 186.67 lakhs with Government of India's share of Rs. 140.00 lakhs.

#### Oil Seeds Cultivation in Orissa

2470. SHRI BHAGABAN MAJHI: Will the Minister of AGRICULTURE be pleased to state:

(a) whether Government have identified the areas which are suitable for oil seeds cultivation in Orissa;

(b) if so, the details thereof;

(c) whether any scheme has been drawn up to increase oil seeds cultivation in those areas;

(d) if so, the target set for Eighth Plan; and

(e) the details of such scheme?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI S. KRISHNA KUMAR): (a) and (b) The suitable districts which have been identified for oilseeds cultivation in Orissa State are Bolangir, Balasore, Cuttack, Dhenkanal, Ganjam, Kalahandi, Keonjhar, Mayurbhanj, Koraput, Phulwani, Puri, Sambalpur and Sundergarh.

(c) and (e) To increase the production of oilseeds, a Centrally Sponsored Oilseeds Production Programme (OPP) in operation in these districts. The assistance under OPP is provided for production and distribution of seeds, seeds minikits, infrastructure development of seeds farms distribution of improved farm implements, sprinkler sets, rhizobium culture, gypsum pyrite micro-nutrients, organising general & frontline demonstrations and training of farmers.

(d) The Eighth Plan target for oilseeds production has been fixed at 12.30 lakhs tonnes by the Government of Orissa.

#### Promotion of Beekeeping

2471. SHRI BHAGABAN MAJHI: Will the Minister of AGRICULTURE be pleased to state:

(a) whether Government have introduced a centrally sponsored scheme to promote beekeeping;

(b) if so, the states where such a scheme is being introduced;

(c) whether this scheme has been launched in Orissa;

(d) if not, the possibility explored in that regard; and

(e) the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ARVIND NETAM): (a) to (e) Government is contemplating to introduce a scheme to promote beekeeping for improving crop productivity during the current Plan. Details of the scheme are being worked out for approval by the competent authority.

#### **Increase in production of Wheat and Rice**

2472. SHRI SURESH PACHOURI: Will the Minister of AGRICULTURE be pleased to state:

(a) whether Indian farmers have once again brought the country to a "State of Plenty" as production of wheat and rice has increased considerably;

(b) if so, what is the buffer stock at present;

(c) to what extent it is more in comparison to the last year,

(d) whether Government are in a position now to export both the wheat and rice during 1994-95;

(e) whether arrangements have been made by Government to keep buffer stock safe; and

(f) whether Government are planning to set up more godowns to keep buffer stocks safe?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ARVIND NETAM): (a) The production of Rice and Wheat is likely to be 78 million tonnes and 58 million tonnes respectively during 1993-94 surpassing all previous records.

(b) and (c) the level of stocks of Rice and Wheat in the Central Pool as on 1.7.1994 and 1.7A 993 as against the minimum buffer stocks norms to be maintained as on 1st July every year was as follows:—

(d) Under the extant of Export Policy, export of superior varieties of Wheat (Durum Wheat) is allowed subject to a Minimum Export Price (MEP) of US \$ 160 PMT and a quantitative ceiling of 3 lakhs tonne. The export of Basmati Rice is freely allowed. There is no restriction on the quantity and no MEP has been prescribed for such exports. Export of superior varieties of Non-Basmati Rice only is allowed subject to a MEP of US \$200 PMT. During 1994-95 Rice and Wheat will be exported as per the provisions of Exim Policy.

(e) and (f) Yes, Sir. The storage capacity (Covered and CAP) available with the Food Corporation of India (FCI) as on 1.7.1994 was about 256.69 lakhs MTs. In order to take care of any additional need the FCI has been delegated powers for hiring additional storage capacity. The Government has plans to construct more godowns in hilly, inaccessible and backward areas.

#### **Diseases in Poultry Sector**

2473. SHRI BHUPINDER SINGH MANN: Will the Minister of AGRICULTURE be pleased to state:

(a) whether Government are aware that I.B.D. and I.B.H. diseases in poultry have spread at several places which have caused great loss to this sector;

(b) if so, whether Government have estimated the loss incurred thereon especially in Batala, Ludhiana, Gurdaspur and Amritsar districts of Punjab;

(c) the steps taken/being taken to compensate for such losses; and
