Vocational Education At Degree Level

*297. SHRI SURESH PACHOURI: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether Government's decision to introduce vocational courses at the degree college level from the current academic year is long overdue;
- (b)if so, whether Government have given effect to the recommendations to the Expert Committee appointed by the UGC which had suggested the introduction of 35 vocational courses in 100 odd colleges;
- (c) if so, whether during 1993 these courses had been extended to the lower second stage;
- (d) whether vocational these educational courses can pressure higher education;
- whether it has been (e) pointed out by the experts that Rs. Ill crore would be

required to

implement the programme for 4 years;

- (f) whether his Ministry had been urging for greater fund allocation to vocational education; and
- (g) what are the programmes that have been prepared for giving improvement to the vocational education during 1994-

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) and (b) The University Grants Commission has decided to assist the universities and college for starting vocational courses at graduate level from the academic year

- 1994-95. The Commission will provide assistance according to the norms developed by it for each individual course.
- (c) A Centrally sponsored Scheme of pre- vocational education at lower secondary stage was introduced during 1993-94 under which assistance is given to States / U.T.s for introduction of vocational courses in class IX and X with a view to imparting training to the students in simple marketable skills and also to prepare them fbr participation in work as a desired dimension of academic education.
- (d) The introduction of vocational courses at the 1st degree stage is expected to provide knowledge and skills required for entry into gainful employment, particularly employment. This measure is expected to ease pressure on the post-graduate level of education.
- (e) Yes, Sir. Funds for implementation of the programme would be provided to the UGC from year to year subject to actual availability of plan resources.
- (f) The implementation vocational courses at the first-degree level is commencing from the current session. The Ministry has in the past been urging for higher allocation of resources for the vocan'onalisation of Secondary education programme.
- (g) The measures for strengthening vocational education include setting up of a Central Institute of Vocational Education, introduction of vocational courses at the first degree level, effective use of professionals to ensure practical and standards, greater with agencies in the orientation and standards, interaction employment market etc.
