## **Road Construction Works in Tamil** Nadu

3045. SHRI V. RAJAN CHELL-APPA: Will the Minister of SURFACE TRANSPORT be pleased to state:

- (a) the details of on-going road construction works in Tamil Nadu sanctioned by the Central Government under Central Road Fund;
- (b) the details and estimated costs involved therein:
- (c) the funds allocated by Government for these schemes;
- (d) whether the complete amount has been sanctioned by the Central Government; and
- (e) if not, the time by when the balance is likely to be released?

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE TRAN-SPORT (SHRI JAGDISH TYTLER): (a) and (b) Fifteen schemes amounting to Rs. 1066.44 lakh relating to Roads and Bridges are under execution in Tamil Nadu under Central Road Fund.

(c) to (e) Allocation of funds is done under Central Road Fund in lump-sum and not work-wise taking into account the total cost of schemes approved for the State, total funds released previously, inter-se priority on All India basis, requirements projected by the State and availability of budget provision. However, funds released to Tamil Nadu for on-going works under Central Road Fund during the last three years, yearwise is as under:-

Year	Rs. in lakh
1991-92	60.00
1992-93	50.00
1993-94	80.00

Since release of funds under Central Road Fund depends upon the availability of budget provision, it is difficult to indicate the time by when the balance would be released.

- (d) No Sir, the average turn round time for ships at Major Ports in India has improved from 7.5 days in 1992-93 to 6.9 days in 1993-94.
- (e) During the Eight Five Year Plan an out-lay of Rs. 2948.00 crores has been provided for modernising the ports and improving thier productivity.

THE MINISTER OF STATE IN THE MINISTRY OF SURFACE TRANSPORT (SHRI JAGDISH TYTLER): (a) It is envisaged to increase the capacity of major ports from 169.23 million tonnes to 237.09 million tonnes on account of development schemes included in the 8th Plan, out of which 216.0 million tonnes is expected to be achieved by the end of 8th Plan.

- (b) The actual capacity as on 31.3.94 is around 173.0 million tonnes. It is not possible to compare capacity addition on the basis of annual growth rate.
