SATISH SHARMA): (a) Surveys are presently continuing in the sedimentary basins of Cambay, Upper-Assam, Assam-Arakan Fold Belt, Krishna-Godavari, Cauvery, Rajasthan, Bengal, Himalayan Foothills & Ganga Valley in the onland and Western and Eastern Offshore areas.

- (b) Hydrocarbons have already been discovered in the sedimentary basins of Cambay, Upper-Assam, Assam-Arakan Fold Belt, Rajasthan, Krishna Godavari, Cauvery and Western and Eastern Offshore areas.
- (c) With a view to increase oil production ONGC Ltd. and OIL have extensive programmes development of these fields. To further supplement the efforts of ONGC Ltd. and OIL, the Govt, of India have invited bid offers from private and foreign companies for development of 73 small and medium sized fields in the first and second rounds.
- (d) For exploitation of oil and gas fields ONGC Ltd. and OIL have proposed a total outlay of Rs. 13,535.62 crores for the remaining period of VIII Plan (1994-95 to 1996-97).
- (e) Both exploration and exploitation for hydrocarbons are continuing.

Establishment of a National Grid for Distribution of Natural Gas

(c) uniform landfall price of gas has been fixed at present all over the country except for the North Eastern States where a concessional price has been allowed in order to encourage the utilisation of gas in the North-East.
