- (b) whether NIRD undertakes training of elected Panchayati Raj functionaries;
- (c) whether there are plans to expand activities of NIRD; and
  - (d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (DEPARTMENT OF RURAL DEVELOPMENT) SHRI RAMESHWAR THAKUR); (a) The National Institute of Rural Development in close Coordination with the Ministry of Rural Development is playing an important role in making the new Panchayati Raj System a success. It has also interalia been associated with consultations on the drafting of the 73rd Constitution Amendment Bill, framing or State Legislations, training and the preparation of reference material.

## (b) Yes, Sir.

(c) and (d) Yes, Sir. The Institute intends to organise additional training programmes for elected representatives of Panchayati Raj bodies. The NIRD is planning to expand its training network to create awareness among grassroot leaders for Panchayati Raj and microlevel planners. The NIRD has already conducted 19 Training of Trainers (TOT) programmes in Panchayati Raj and plans to conduct additional programmes during the current year.

Development of SC and ST area of village Mirpur Dahora was spent in non-SC and non-ST areas by Pradhan of this village;

- (c) whether on complaint from villagers the BDO made an enquiry on 23rd April, 1994 and he submitted his report to CDO, Aligarh under No. 1700 on 3rd May, 1994;
- (d) whether as per enquiry report any action has been taken against village Pradhan for spending sanctioned Rs. 50,000/- in other areas and thus depriving sheduled Caste areas;
- (e) what further action is being taken to ensure that SC and ST areas of village Mirpur Dahora get the benefit of the sanctioned amount?
