(e) and (f) The IEDC Scheme, is presently being implemented through the Department/ Directorate of Education of 24 State Governments / UT Administrations. In Punjab, the Directorate of Public Instruction (School) is the implementing agency for this Scheme. In addition, the Government of Punjab, through its Social Welfare Department, is implementing a scheme known as "Scholarships to the physically handicapped persons". Under this scheme, scholarships are provided to physically handicapped persons who are studying in schools, colleges and universities.
