(c) whether the UGC is extending any financial assistance to these Open Universities; and

(d) if so, the details of assistance given-by UGC to these Open Universities?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (KUMARI SEUA): (a) According to the information furnished by the University Grants Commission (UGC), the following Universities are presently functioning as Open Universities:—

1.- Dr. B.R. Ambedkar University, Hyderabad

2. Indira Gandhi National Open University, New Delhi

3. Kota Open University, Kota

4. Yashwantrao Chavan Maharashtra Open University, Nasik

Universities are not affiliated to the U.G.C.

(b) As per provisions of Section 5, of the IGNOU Act, the University has set up a Distance Education Council to look after the Open University/Distance Education system for the promotion, coordination and determination of their standards. Distance Education Council is taking steps for networking the State Open Universities for sharing courses and programmes for all Open Universities, and developing a pattern and structure for the Open University Programme that would facilitate student mobility among programmes.

(c) No Sir.

(d) IGNOU is fully funded by the Government of India whereas the State Open Universities receive financial support from the Indira Gandhi National Open University on the recommendation of Distance, Education Council. Such assistance includes support to develop new programmes and courses. Besides, course materials already produced by the IGNOU and other Open Universities are made available to new State Open Universities so that access to Open University Programme is widened.
