(b) and (c) Type-V house No. 193, Rouse Avenue, has been allotted to INDUSIND FOUNDATION on 8.10.93, on temporary basis. for a period of 2 years, pending construction of its headquarters in Delhi. The allotment has been made, as a special case, with a view to enable the organisation to begin immediately its cultural and welfare activities for the benefit of Sindhi Community.

## Killing up of Posts in CPWD

- (a) whether it is a fact that orders were issued in May. 1993 to till up 1610 posts of different categories of CPWD staff rendered vacant on absorption of CPWD staff in National

Airport Authority;

- (b) if so, whether it is also a fact that orders were issued subsequently to withdraw some of these posts from different zones of the Department; and
- (c) if so, the reasons therefor and what is the present position of posts of different categories utilised by different Zones and posts lying unutilised so far with the D.G.W., C.P.W.D.?

- (c) Due to non-availability of eligible daily rated workers in Eastern Zone, 313 posts allocated to that Zone were withdrawn by CPWD to be utilised in other Zones, where eligible daily rated workers were available for regularisation. Out of 1610 posts rendered vacant on absorption of CPWD staff in the National Airports Authority, the services of some of the eligible daily rated workers engaged before imposition of ban on recruitment of daily rated workers, i.e. 18.11.85 have already been regularised according to their seniority and the left out eligible daily rated workers are also being considered for regularisation against the remaining posts.
