Deep sea shrimp resources off coast of Orissa

3881. SHRI BHAGABAN MAJHI: Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

(a) whether Government have made any assessment in the deep sea shrimp resources off the coast of Orissa;

(b) if so, the details of the estimated deep sea shrimp resources off the Orissa coast as per the last assessment;

(c) what steps are being taken for the proper exploitation of shrimp resources off the Orissa coast; and

(d) what are the details thereof?

THE MINISTER OF STATE OF THE MINISTRY OF FOOD PROCESSING INDUSTRIES (SHRI TARUN GOGOI): (a) and (b) Assessment of deep sea shrimp resources along East Coast, has been made by the Fishery Survey of India. However, no specific survey for Orissa alone has been under taken. The annual potential yield of deep sea shrimp has been assessed at 100 tons along the upper East coast.

(c) and (d) Government encourages in production of resource specific vessels for exploitation of target fishes. However, such exploitation depends on commercial viability of operations in a particular area.

Food Processing units in tribal areas

(a) whether Government have set up some Food processing units in the tribal areas of the country;

(b) if so, the Statewise details thereof;

(c) whether proposals have been received both from the State Government as well as private sectors to set up food processing units in the tribal areas;

(d) whether any such proposal has been received by the Government for setting up food processing units in Orissa; and

(e) if so, the details thereof?

THE MINISTER OF STATE OF THE MINISTRY OF FOOD PROCESSING INDUSTRIES (SHRI TARUN GOGOI): (a) and (b) The Ministry of Food Processing Industries does not set up Food Processing units directly. However, under various Plan Schemes of processing industries.

(c) Yes, Sir.

(d) and (e) While one 100% E.O.U. project with an investment of Rs. 112.5 lakhs have been approved for Koraput district, the assistance to the extent of Rs. 24.34 lakhs have been extended by this Ministry for upgrading of Fruit and Vegetables processing unit at Koraput and another Rs. 10.00 lakhs assistance have been extended as equity for setting up of tomato and mango processing unit at Keonjhar. The Ministry has also provided assistance to the extent of Rs. 29.43 lakhs for setting up of Food Processing Training Centre at Sundergarh, Pan posh, Balasore, Sambhalpur, Kenjhor and Koraput districts in Orissa.
