

मोकामा और राजमहल के बीच "फेरी सेवा"

4032. श्री नरेश यादव:

क्या जलभूतल परिवहन मंत्रों यह बताने की कृपा करेंगे कि:

(क) सरकार द्वारा बिहार राज्य में मोकामा और राजमहल के बीच गंगा नदी पर लगभग 300 किलोमीटर की दूरी तक के लिए कितनी फेरी सेवाएं चलाई जा रही हैं;

(ख) यदि नहीं, तो उसके क्या कारण हैं; और

(ग) क्या सरकार इस क्षेत्र की इस गंभीर समस्या पर गंभीरतापूर्वक विचार करने के उपरान्त कोई ठोस कदम उठाने का विचार रखती है?

जलभूतल परिवहन मंत्रालय के राज्य मंत्री (श्री जगदीश टाईटलर): (क) से (ग) चूंकि फेरी सेवाओं का प्रचालन, संविधान के अंतर्गत, राज्य का एक विषय है इसलिए केन्द्र सरकार का बिहार में मोकामह और राजमहल के बीच फेरी सेवाएं चलाने का कोई प्रस्ताव नहीं है।

Dredging the Hooghly River

4033. SHRI RAMNARAYAN GOSWAMI: Will the Minister of SURFACE TRANSPORT be pleased to state the amount spent during 1984—93 to dredge the Hooghly river and whether Government are satisfied that as a result of such spending, a proper and desirable draught level has been maintained for the Haldia Port?

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE TRANSPORT (SHRI JAGDISH TYTLER): A total amount of Rs. 383.48 crores has been spent during the period 1984—93 on maintenance dredging in the river Hooghly.

The navigability in the river Hooghly has been maintained

Breakdown of dredging ship of Calcutta Port

4034. SHRI RAMNARAYAN GOSWAMI: Will the Minister of SURFACE TRANSPORT be pleased to state:

(a) what steps are being taken to resume dredging by Calcutta Port following the breakdown of the dredging ship; and

(b) what compensations are being demanded from the foreign company concerned

second hand ship to which sold the Government?

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE TRANSPORT (SHRI JAGDISH TYTLER): (a) there was no breakdown of any dredger in Calcutta. It was the pipeline for carrying the dredged material that failed. Dredging Corporation of India is expected to start dredging in Haldia after the monsoon.

(b) A claim of Rs. 75.52 crores has been preferred by the Calcutta Port Trust.
