The performance of States in the realisation of plan targets is also monitored through official level discussions with the States, visits of the Commission to the States, and in discussions between Deputy Chairman, Planning Commission and Chief Ministers of Stales. In addition, the release of Central Assistance to States for Plan projects/programmes are based on the Utilisation Certificates and Progress Reports.

(c) The States which have signed Memorandum of Understanding (MOUs) for Fiscal Reforms during 1999-2000 arc: Andhra Pradesh, Assam, Himachal Pradesh, Jammu & Kashmir, Madhya Pradesh, Manipur, Mizoram, Nagaland, Orissa, Punjab, Rajasthan, Sikkim and Uttar Pradesh.
