Memorandum for Financial Assistance to Orissa

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ARVIND NETAM): (a) Government of Orissa submitted a Memorandum seeking Central assistance of Rs. 138.41 crores, to the Union Minister of Civil Supplies, Consumer Affairs and Public Distribution during his visit to State. Members of Parliament and MLAs also met the Minister during his visit.

(b) In addition to the normal release of 1 st & 2nd instalments of Central share of Calamity Relief Fund for the year 1994-95, Government of India have also released the 3rd & 4th instalments amounting to Rs. 14.89 crores in advance, in order to enable the State Government to undertake flood relief measures.

Drip Irrigation

4260. SHRI BHUPINDER SINGH MANN: Will the Minister AGRICULTURE be pleased to state:

- (a) what technological and financial assistance is being provide for dripirrigation by Central Government, Statewise details;
- (b) whether any assistance is being provided by State Government also; if so, the

details thereof; and

(c) whether any estimate as to what quantity of water can be save by this technology has been made; if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE ARVIND NETAM): Government of India is implementing a centrally sponsored scheme on "Use of Plastics" in Agricultures which inter alia covers assistance to the farmers for promoting use of drip irrigation for horticulture crops with an outlay of Rs. 200 crores during VIII Plan. The scheme also provides for laying demonstrations on drip irrigation in governmental & public sector/Trust farms in every State/UT and training of users on handling of different drip system package of practices etc. The state-wise details of the funds released form 90-91 to 93-94 and allocation for 94-95 are given in the enclosed statement (see below).

(b) A few States like Maharashtra and UP are supplementing the Central assistance from their own budgetary sources to cover large areas and beneficiaries.
