क्या जल संसाधन मंत्री यह बताने की कृपा करेंगे कि:

- (क) क्या देश के विभिन्न नदी-थालों (बेसिनों) के लिए कोई बाढ़ नियंत्रण संबंधी मास्टर प्लान तैयार कर लिया गया है:
 - (ख) यदि हां तो इसका ब्यौरा क्या है: और
 - (ग) यदि नहीं, तो इसके क्या कारण हैं?

शहरी विकास मंत्रालय और जल संसाधन मंत्रालय में राज्य मंत्री (श्री पी. के. थुंगन): (क) से (ग) वर्ष 1972 में गंगा बाढ़ नियंत्रण बोर्ड गठित किया गया था जिसका सचिवालय गंगा बाढ़ नियंत्रण आयोग है।

गंगा बाढ़ नियंत्रण आयोग ने गंगा की सभी 23 नदी प्रणालियों के बाढ़ प्रबंध के वास्ते व्यापक मास्टर योजनाएं तैयार की हैं। इसी प्रकार 1981 में गठित ब्रह्मपुत्र बोर्ड ने ब्रह्मपुत्र और बराक थालों के बाढ़ प्रबंध के लिए व्यापक मास्टर योजनाएं तैयार की हैं। ये मास्टर योजनाएं दीर्घावधिक और अल्पावधिक सिफारिशों के साथ राज्य सरकार को भेजी गई हैं कि वे भू-सर्वेक्षण, अन्वेषण करने के बाद विस्तृत योजनाएं तैयार करके उनका क्रियान्वयन करें।

International lending for Flood Control Projects

4392. SHRI JALALUDIN ANSARI: SHRI CHATURANAN MISHRA:

Will the Minister of WATER RESOURCES be pleased to state:

- (a) whether it is a fact that Government are planning to put across certain potentially effective flood control projects to international lending institutions for financial assistance;
- (b) if so, the detail thereof; and if not, the reasons therefor; and
- (c) what steps Government propose to take with regard to formulation of an economically, socially and environmentally acceptable flood management strategy?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT AND THE MINISTRY OF WATER RESOURCES (SHRI P.K. THUNGON): (a) and

- (b) A proposal seeking external assistance for funding major flood management schemes in the flood prone States is under consideration of the Government. Specific schemes and the source of external assistance has not been identified.
- (c) The investigations, planning and execution of flood control schemes are primarily the responsibilities of the State Governments. The Centre renders assistance in works that are technical, catalytical and promotional in nature. The Central Government has set up Ganga Flood Control Board with its Secretariat at Ganga Flood Control Commission in 1972 and Brahmanutra Board in 1981. The Ganga Flood Control Commission has prepared comprehensive master plans for flood management for all the 23 river systems of Ganga. Similarly, Brahmaputra Board has prepared comprehensive master plans for flood management in Brahmaputra and Barak basins. These master plans along with the long term and short term recommendations have been sent to State Governments for formulating details schemes after carrying out ground surveys, investigations and taking up their implementation.

Tribal Development programme in Gujarat

- (c) whether it is a fact that the tribals have to face many difficulties in obtaining Government's aid and they are harassed to a great extent by Government officials and the Government procedures;
- (d) whether Government are taking any concrete measures to make them obtain the aid easily; and
