- (b) who is the head of the Governing Body of the Nehru Memorial Museum and Library and when he was appointed;
- (c) who are the members of the Governing Body of the institution and whether all of them are party to the decision of extension by five years; and
- (d) if so, what are the extra ordinary reasons for decision of extension for five years?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPTT, OF EDUCATION AND DEPTT. OF CULTURE) (KUMARI SELJA): (a) Director, Nehru Memorial Museum and Library has been granted extension in service for a period of five years w.e.f. 1.12.92 till 30.11.97 with the approval of the competent authrority.

- (b) Shri Narayan Dutt Tiwari is the Chairman of the Executive Council of the Nehru Memorial Museum and Library which was constituted in September, 1987.

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA): (a) Yes, Sir.

- (b) All the Sainik Schools in the country are administered by the Sainik School Society, a unit of the Ministry of Defence. As per information received from the Ministry of Defence, none of the Principals of Sainik Schools has informed the Sainik School Society about any Union Territory not paying the scholarship at the rates stipulated with effect from the academic year 1986-87.
- (c) and (d) A representation dated 16.6.1994 from the parent of a student studying in Sainik School, Sujanpur Tihra, Hamirpur (H.P.) has been received requesting for revision of income slabs for determining eligibility to the grant of scholarship for students of UTs studying in Sainik Schools. The Ministry of Defence has informed that following the decision taken by the Executive Committee of the Sainik School Society in its meeting held in December, 1993, the State Governments were requested by the Society to consider the revision of income slabs for the purpose of grant of scholarship to Sainik School students. Revision of income slabs for the purpose of grant of scholarship to students of Union Territories studying in Sainik Schools would

depend on views of the State Governments in this regard.
