THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA): (a) to (c) Kendriya Vidyalaya Sangathan has intimated that the Board of Governors of Kendriya Vidyalaya Sangathan in their 51st meeting held on 31.5.88 decided that a sub-Committee may be constituted by the Chairman, Kendriya Vidyalaya Sangathan to go into the question of admission on special dispensation and the Chairman, Kendriya Vidyalaya Sangathan may take a decision in the light of the report of the Sub-Committee. The Sub-Comittee was chaired by Sh. Chandulal Chandrakar, M.P. Accordingly the Chairman had, after considering the report of the Sub-Committee, decided that admissions by special dispensation should be resumed in the larger social consideration.
