II. TERMS OF REFERENCE

The Committee will

a. suggest welfare programmes to be implemented at the national level for the care, protection, treatment, development and rehabilitation of the young fallen victims, namely, the children and the girls.

b. make suggestions for amendments to the existing laws or for enactment of any new law, if so warranted, for the prevention of sexual exploitation of children.

c. examine the Devadasi system and the login tradition and suggest ways and measures for the eradication of these systems and for the rehabilitation of the victims of such traditional forms of exploitation.

Pay fixation of Assistant Teachers in the Senior Scale in MCD Schools

4325. PROF. I.G. SANADI: Will the Minister of HUMAN - RESOURCE DEVELOPMENT be pleased to refer to the answer to Unstarred Question 4500 given in the Rajya Sabha on 27th August, 1993 regarding pay fixation of Assistant Teachers in MCD and state:

(a) whether relevant orders regarding placement of 101 Assistant Teachers in Senior Scale (Rs. 1400-2600) approved by the DPC held on 14th June, 1990 in Karol Bagh Zone, Delhi and whose names were appeared in the list issued by Education Department of MCD

were issued by the zonal office of the MCD;

- (b) if so, whether 101 Assistant Teachers were asked to exercise their option within one month with regard to fixation of their pay in the Senior Scale;
 - (c) if so, the details thereof; and
- (d) if not, what remedial measures are proposed to be taken in respect of the Assistant Teachers, who could not exercise their option within a stipulated period in the absence of any communication from MCD, to avoid recurring monetary loss to such affected teachers of MCD?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARISEUA): (a) to (d). Yes, Sir. The Municipal Corporation of Delhi has intimated that the Government instructions regarding option to be exercised for fixation of pay was circulated to all the Zonal Assistant Education Officers vide their Circular dated 3.8.1989. These instructions were displayed by Zonal Assistant Education Officers for information and necessary action by the concerned teachers. Such option should have been exercised by the teachers within one month from the date of such appointments as per instructions.

Licences for exploration in Minable

Aluminium produced in Damanjodi Plant in Orissa

- 4327. SHRI BHAGABAN MAJHI: Will the Minister of MINES be pleased
- (a) whether it is a fact that the Aluminium product in Damaniodi plant in undivided Koraput district, Orissa has great demand in the International market;
- (b) if so, the steps taken to increase the production and export of aluminium;

THE MINISTER OF STATE OF THE MINISTRY OF MINES (SHRI BALRAM SINGH YADAV): (a) to (d). National Aluminium Company Limited (NALCO) has an Alumina Refinery at Damanjodi in Koraput district of Orissa. Alumina produced in the above plant is of international quality but demand for Alumina in the International Market has been depressed since 1993 due to glut of Alumina. The Company is producing Alumina as per plans and has planed to export 3.75 lakh metric tonnes during 1994-95. The Company hopes to maintain this level of export during the 9th plan period.
