National Computer Centre at Hyderabad

4292. SHRI IQBAL SINGH: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether Government propose to set up

a national computer centre at Hyderabad in the name of former Prime Minister Shri Rajiv Gandhi;

(b) if so, the details thereof in this respect;

(c) by when it is likely to be set up; and

(d) what effective measures are being taken by Government with regard to opening its branches in various States of the country particularly in the State of Punjab?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SEUA): (a) to (d) Government in principle have decided to set up Rajiv Gandhi National Institute of Computer & Allied Sciences. The Institute would undertake both higher education and advanced research in Computer Science and its applications in various fields of Science and Technology. A detailed project report is proposed to be got prepared through a professional agency under the guidance of a National Steering Committee. The location of said National Institute has not yet been decided. There is no proposal to open any branch or centre.

Reservation in Private Medical and Engineering Colleges

4293. SHRI PRAKASH YASHWANT AMBEDKAR: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether for the year 1991-92, 1992-93 and 1993-94 all seats reserved for Scheduled Castes and Scheduled Tribes in Medical and Engineering Colleges, were filled at Central and State levels;

(b) at what percentage the admission was granted and at what percentage it closed, State-wise;

(c) whether in private Medical and Engineering colleges the reservation policy is followed; and

(d) if so, the number of students admitted from Scheduled Castes and Scheduled Tribes and the number of students from the Nomadic Tribes and at what percentage?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA): (a) to (d) Admissions to Central Institutions are made as per the reservation policy of Government of India and admissions to the State Institutions are made as per the reservation policy of the respective States/ Union Territories. The Supreme Court of India in its judgement dated 4-2-93 prescribed a scheme for regulating admissions to private professional unaided institutions. According to this scheme, it shall be open to a professional college to provide for reservation of seats for constitutionally permissible classes. State-wise details of the number of students admitted from reserved categories, the percentages at which such admissions were granted and closed etc. are not available.

Import of Books

4294. SHRI ASHOK MITRA: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) the total value of import of books in each of the years since 1984-85;

(b) the proportion of scientific, technical and educational books in these imports; and

(c) whether Government would consider requesting the Reserve Bank of India to grant a concessional rate for foreign exchange released for the import of scientific and educational books?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SEUA): (a) and (b) A statement is annexed, (*see* below) Classified data is not being maintained by the Directorate General of Foreign Trade (Ministry of Commerce).

(c) After the unification of exchange rate with effect from 1 st March, 1994 all the foreign exchange transactions for imports are at market determined exchange rate. There is, therefore, no mechanism under which concessional rate

for foreign exchange release can be considered for any imports.
