THE MINISTER OF STATE OF THE MINISTRY OF FOOD (SHRI KALP NATH RAI): (a) to (c). As on 31.7.1994, 292 applications have been received through the Department in Industrial Development for setting up of new sugar factories in the cooperative sector in the country. Of these, 282 applications have already been scrutinised by the Screening Committee. After examination. recommendations of the Ministry of Food were sent to the Ministry of Industry for consideration by the licensing Committee. The remaining 10 applications are still under consideration in the Ministry of Food. After their scrutiny by the screening Committee, the recommendation of the Ministry of Food inrespect of these applications will be sent for consideration by the Licensing Committee, after which letters of intent/ licences will be issued by the Ministry of Industry.

(d) and (e) A statement showing the location-wise details of the applications received through the Department of Industrial Development for setting up of new sugar factories in the co-operative sector is at Annexure [See Appendix 171, Annexure No. 74]

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF WOMEN AND CHILD DEVELOPMENT) (SHRIMATI BASAVARAJESWARI): (a) Details of food items served to children in Anganwadis under Integrated Child Development Service (ICDS) Scheme are given in Statement-A (see below). Further, the children in two Navodaya Vidyalayas in Delhi, are provided with bed tea, breakfast, lunch, afternoon tea / coffee / beverages with snacks and dinner and the food items mainly include rice, dal, atta, vegetable oil, sugar, suji, milk, curd & vegetables.

(b) Sources of purchase of the food items under the ICDS Scheme in Delhi are given in Statement "A'. For purchase of food items under the ICDS Scheme, the Delhi Administration floats tender notice which are published in leading Newspapers. The quotations received in response to the tender notice are examined by the purchase committee. Thereafter, the samples of valid tenders are sent to Government Laboratory, Krishi Bhavan, for chemical analysis. On receipt of satisfactory test reports, the rates are checked and tender awarded.

As regards Navodaya Vidyalayas, bulk items such as rice, dal, atta, vegetable oil, sugar, suji etc. are mostly purchased from the District Supply Offices / Super Markets / Corporations etc., other items like milk, curd, vegetables etc. are purchased from suppliers identified after floating tenders or calling spot quotations, as per rules.

(c) Details on quantity item-wise, given to the children under the ICDS Scheme are in statement-"C" (See below). However, the children in Navodaya Vidyalayas are provide with food items at an average cost norm of

- Rs. 350 per child per month.
- (d) Details of items purchased alongwith cost and source of their purchase during the last three years, year-wise for providing supplementary nutrition under the ICDS Scheme are given in Statement-"B' (see below).
- (e) During the current year, till date, 15 samples have been sent for analysis under the ICDS Scheme, and none has been found to be substandard or adulterated.
- (f) The food items, under the ICDS Scheme, are purchased following a definite procedure and there is no bar on Kendriya Bhandar responding to the tender notice floated by Delhi Administration.
- (g) and (h) The firm manufacturing Parle Biscuits or Kendriya Bhandar can submit tenders at the appropriate time when new tenders are invited for supply of food to the beneficiaries under the ICDS Scheme. For supply of food items for children in Navodaya Vidyalayas, the Navodaya Vidyalaya Samiti is not in a position to assure purchase of a particular brand product.
