Reservation in Education and Jobs in Tamil Nadu

Will the Minister of WELFARE be pleased to state:

(a) whether Government are aware that some national and regional political parties and leaders have favoured 69% reservation in education and jobs in Tamil Nadu; if so, the details thereof;

(b) whether the State Government of Tamil Nadu has earmarked the creamy layer; and

(c) whether it is a fact that in open competition category 80—85% of the candidates belong to the reserved category in Tamil Nadu?

THE MINISTER OF WELFARE (SHRI SITARAM KESRI): (a) On 13 July, 1994, the Union Home Minister held a meeting with leaders of major political parties to seek a consensus on the question of giving President's assent to Tamil Nadu Backward Classes,
