Employment of Handicapped Persons in ICDS Programme

(a) whether there are specific guidelines for local officers of Integrated Child Development Scheme (ICDS) programme in districts to give preference to handicapped and qualified people in the matter of employment;

(b) whether it is a fact that in many instances in Andhra Pradesh qualified and handicapped people are not being selected;

(c) whether Government have received any information on such cases from West Godavari District, Andhra Pradesh; and

(d) the steps proposed to ensure that handicapped people are also given employment in ICDS programme?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF WOMAN AND CHILD DEVELOPMENT) (SHRIMATI BASAVARAJESWARI): (a) and (b) No, Sir. The guidelines under the Integrated Child Development Services (ICDS) Scheme only prescribe technical qualification for the local officers of the ICDS Projects.

(c) and (d) The Government have received only one request for the appointment of handicapped person as Anganwadi worker in the West Godavari District, which has been forwarded to the State Government for appropriate action.
