## Construction of speed-breakers in busy roads

KRISHNAN: Will the Minister of SURFACE PORT be pleased to state the concept or parameters, if any laid down by the Central Government for the construction of new speed\_breakers in the busy roads in the capital or elsewhere, under the jurisdiction of the Ministry of Surface Transport?

THE MINISTER OF STATE MINISTRY OF SURFACE THE TRANSPORT (SHRI JAGDISH TYT-LER): The Ministry of Surface Transport is primarily responsible for roads declared as National Highways

all categories of roads other than National Highways are the responsibility of State Governments. Therefore. construction of speed breakers on the busy roads in the Capital and other State roads is the responsibility of State/Union Territory Governments. Government of India's policy has all along been not to construct speed breakers, remove the existing ones and provide alternative safety measures like rumble strips, flashing signals. etc., on National High ways, in the interest of road safety and smooth flow of traffic.
