THE MINISTER OF CIVIL AVIA-TION AND TOURISM (SHRI GHU-LAM NABI AZAD): (a) The guidelines are indicated in the annexure. [See Appendix 170, annexure No. 6).

(b) and (c) The guidelines are rally being compiled with the Air Taxi Operators as and when any deviation is no iced corrective action is taken.
