# S. C. Judgement regarding promotion of Central Government employees

482, PROF. VIJAY KUMAR MAL-HOTRA: Will the PRIME MINISTER be pleased to state;

- (a) whether Government's attention has been drawn to the judgement of the Supreme Court in the case of Dr. Ms. O.Z. Hussain vs Union of India (ATR 1990(1) SC437) regarding promotion of Central Government employees;
  - (b) if so, the facts thereof; and
- (c) the action taken by Government to implement the judgement?

THE MINISTER OF STATE IN THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS (SMT. MARGARET ALVA): (a) Yes Sir.

(b) and (c) The Supreme Court the above judgement delivered on 15.11. 89 inter alia directed the Ministry Health and Family Welfare to frame appropriate rules providing promotional avenue for the 'A' category scientists in the non-medica' wing of the Director General of Health Services and also extend them the benefit of certain allowances admissible to medical officers. According the Ministry of Health Family Welfare have notified "Department of Health" (Group A Non-Medical Scientific and Technical posts) In-Situ promotion rules 1990 on 28,11,90 providing for promotional ave-The benefit of certain other allowances as admissible to the medical officers has also been extended to them.

# Age for entry into Government Service

483. SHRI O. P. KOHLI: Will the PRIME MINISTER be pleased to state:

- (a) the reasons for fixing 18 and 25 years as minimum and maximum age of entry into Government service;
- (b) whether there is any proposal to review these ages particularly the maximum age keeping in view the coming into effect of the 27 per cent reservation for OBCs; and
  - (c) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS (SMT, MARGARET ALVA): (a) The minimum age of 18 years for entry into Government service has been fixed keeping in view the health requirement mental development, etc. The maximum age limits prescribed for recruitment to various posts under the Central Government range from 25 years upwards depending on level of post, the nature of duties, educational qualification and experience requirements.

(b) and (c) Since reservation for OBCs has been introduced only very recently and recruitments on the basis of this reservation have just started, it is too early to consider whether any age relaxation; required to be extended to candidates belonging to this category.

(b) and (c) The Ministries, Deptts. Offices are themselves responsible planning the measures in the matter of identifying the key areas requiring systems improvement concerning vigilence and anti-corruption work and are quired to take necessary action. As such, Ministries, Deptts, and offices are not required to render any proposal to this Deptt. Administrative Vigilance Division in the Deptt, of Personnel and Training has, however, prescribed quarterly return for the Action Plan in order to collect and review information tion regarding various specific anti-corruption measures, such as number of cases under investigation and disciplinary proceedings etc. The Ministries Deptts. and offices where there are large number of cases pending are advised to effective steps to reduce the same.
