(b) whether it is a fact that the Ayurvedic medicines have proved successful at a very cheap cost in curing patients suffering from blocked arteries and prolonged diseases; and

(c) if so, the steps Government are taking to propagate the use of these Ayurvedic medicines?

THE MINISTER OF HEALTH AND FAMILY WELFARE (DR. C. P. THAKUR): (a) The Government is aware of the news report. Arjuteb is a patent proprietary medicine licenced by Haryana State authorities which is claimed to be useful in treating cardiac problems.

(b) According to the Central Council of Research in Ayurveda & Siddha different plant based drugs like Guggulu (Commiphora wightii), Vaca (Acorus Calamus) have been found to be useful in treating Ischaemic Heart Disease.

(c) In order to establish clinical efficacy of various Ayurvedic drugs long term clinical trials have to be undertaken. Facilities are being offered for undertaking such research. In the meantime, steps have also been taken to encourage more Ayurvedic treatment facilities and improve the quality of the medicines sold to the public.

Market share of Maruti Car
