#### **OBITUARY REFERENCE**

MR CHAIRMAN: Hon. Members, I refer with profound sorrow to the passing away of Shri Nuthalapati Joseph, a former Member of the Rajya Sabha, on the 21st November, 1992 at the age of 77 years.

Born at Chirala Taluq in Prakasam District of Andhra Pradesh, Shri Joseph had his education at Guntur. Shri Joseph joined the freedom movement when he was still in his teens and took active part in the boycutt of the Simon Commission. He participated in the Quit India Movement in 1942 and underwent imprisonment.

A veteran social and trade union leader, Shri Joseph was deeply involved with the problems of backward communities and worked tirelessly to ameliorate their condition. He fought against the scourge of untouchability. Shri Joseph was closely associated with several organisations for the welfare of the weaker sections of the society. Shri Joseph represented the State of Andhra Pradesh in the Rajya Sabha for a period of two years, having been elected in March, 1972.

We deeply mourn the passing away of Shri Nuthalapati Joseph.

I request Members to rise in their places and observe silence as a mark of respect to the memory of the departed.

They are also seeking business opportunities in Malaysia, Saudi Arabia, Kuwait, Baharain and Abu Dhabi in addition to the above countries.
