

Charging of Licence fee from Mobile Operators

† 964. SHRI RAJ MOHINDER SINGH:

SHRI RAJIV RANJAN SINGH:

Will the Minister of COMMUNICATIONS be pleased to state:

(a) whether it is a fact that a proposal is being considered to collect seventeen percent of the total annual income of mobile operators in private sector as annual licence fee;

(b) whether Government intend to implement the said proposal; and

(c) if so, the comprehensive details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI TAPAN SIKDAR): (a) to (c) Sir, as per the recommendations received from Telecom Regulatory Authority of India (TRAI) on 23.6.2000, the Annual Licence Fee to be paid by Mobile Phone Operators should be 17% of the 'Adjusted Gross Revenue*' (except for Andman and Nicobar and Jammu and Kashmir Circles where Annual Licence Fee as 10% of the 'Adjusted Gross Revenue' has been recommended). The Government is considering the recommendations of TRAI. A final decision on revenue share percentage is yet to be taken. The recommendations of TRAI are available on 'tra. gov. in' web site.
