Tapping/monitoring of telephones of Important dignitaries and M.P.s by State Governments

SHRI JOHN F. FERNANDES (Goa): I want to raise a very important issue regarding the tapping of telephones under the garb of monitoring the telephones. In Goa, in the month of October, there was a serious matter about a VVIPs telephone—according to the Blue Book, there are only 3 VVIPs, the President, the Vice-President and the Prime Minister—being tapped by the State police. This has become a common practice Throughout the country where the police authority, the State authority, is transgressing its jurisdiction. The Indian Telegraphs Act is under the jurisdiction of the Central Government. And if any security precaution has to be taken to check hoax calls, it is for the Central Government to direct and it has to be done under the purview of the Blue Book which contains security instructions. I think this is a very common practice not only in Goa but also in other parts of the country. The telephones of Members or Parliament have also been tapped and monitored by the State Government. When I talked to the Home Minister about it, he said that it is the Home Ministry, the Central Government, which can direct it.

THE VICE-CHAIRMAN (SHRI SYED SIBTEY RAZI): Now it is for Private Members' Bills... (*Interruptions*).
